

## **Start the year on the right foot**

### **Contest rules**

1. The contest is held and organized by Desjardins Financial Security Life Assurance Company (“Desjardins Insurance”) and runs from January 1 to March 31, 2020 (contest closing date).

#### ***PARTICIPATION***

2. The contest is open to Desjardins Insurance group retirement savings plan members.
3. To enter, participants must visit the Wellness Centre on the secure member website ([dfs.ca/participant](https://dfs.ca/participant)) between January 1 and March 31, 2020, at 11:59 pm (ET).
4. Employees of a Desjardins Group component and any individual residing with them are not eligible to enter this contest.
5. Participants must be Canadian residents who have reached the age of majority in their province or territory of residence at the time of the draw.
6. No entry form or purchase is required.

#### ***PRIZE***

7. There will be one prize. Participants have the chance to win a prize valued at C\$5,000.
8. The winner will be able to choose from:
  - A cheque or bank deposit **or**
  - An amount that will be immediately deposited, in whole or in part, in the form of a contribution into the winner’s account\* administered by Desjardins Insurance\*\*. This choice will have to be confirmed in writing.

\* Can be an RRSP, TFSA or SPP.

\*\* The winner must ensure that they have sufficient contribution room in the selected registered plan. Any amount deposited into the RRSP or TFSA will affect the winner’s contribution room. A pension adjustment must be declared for the SPP contribution. The amount deposited into the plan will be reported as an employee contribution on the prescribed slips.

#### ***DRAW***

9. The draw will take place on April 6, 2020.

Eligible participants must have a valid email address on file as at 11:59 pm (ET) the day before the draw, which take place at 2:00 pm (ET) on the aforementioned dates at the Desjardins Insurance offices located at 1050 Côte du Beaver Hall, 16th floor, Montreal, Quebec. The prize winner will be drawn at random from all eligible entries received.
11. The odds of winning depend on the number of contest participants. An individual cannot win more than one (1) prize.

## **GENERAL CONDITIONS**

In the days following the draw, the contest organizers will contact the winner by phone or by email, at which time the winner must correctly answer the following skill-testing mathematical question to be entitled to their prize:  $3 \times 4 + 3 - 7$ . If the person does not answer correctly, the contest organizers will hold an electronic draw to select another name from all eligible entries received. If, after ten (10) business days of receiving the email or phone call, the participant whose name was drawn has still not contacted the contest organizers, the contest organizers reserve the right to award the prize to another individual.
13. The prize must be accepted as awarded and may not be transferred to another person (including the winner's successor or heir), substituted or redeemed for cash. In the event that a prize cannot be awarded as described for reasons beyond Desjardins Insurance's control, a substitute prize of equal value will be offered.
