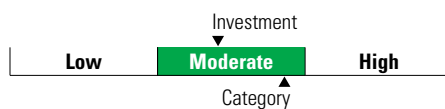

This fund targets an annualized return higher than that of the S&P/TSX Capped Index, over four-year moving periods.

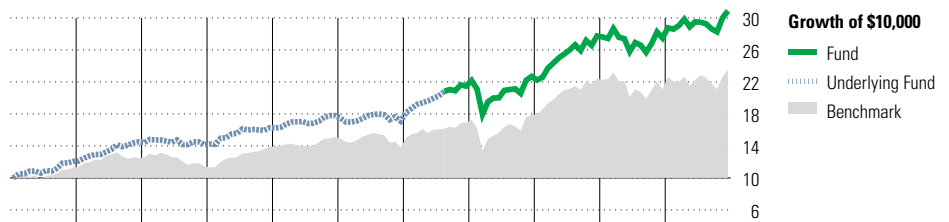

Investment Strategy

This fund, actively managed, aims to provide long-term capital appreciation while seeking to minimize overall portfolio volatility by investing primarily in Canadian equity securities. The fund's asset allocation and securities selection are determined by the manager based on the present policy. The fund's manager combines techniques of bottom-up fundamental research and quantitative analysis to identify and select securities. Quantitative modeling is also used at the portfolio level to aim to reduce the overall volatility.

Performance Analysis as of December 31, 2023



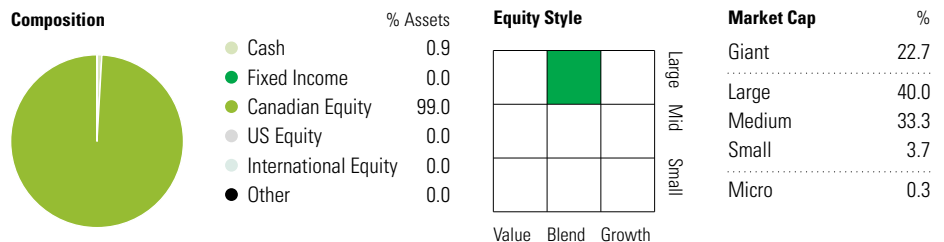
